Annamaria Fabian has teaching and research experience in different fields of (mainly German applied) Linguistics ranging from classical research fields such as grammar and syntax over discourse analysis and pragmatics to conversation analysis and digital linguistics.

In the first half of my academic career in teaching and research I acquired in-depth competencies in empirical research in many research areas, i.e., political communication, media communication, and corporate communication, and necessary corpus linguistic quantitative and qualitative working methods, including Tools and Software for corpus-based and corpus-driven data-mining. I have published different peer-reviewed monographs, volumes and papers at prestigious international publishing-houses and organized panels at world congresses such as AILA, IPrA and IGALA. In addition, I actively pursue science communication with different stakeholders from media, politics and civil society. My interest in emerging related to society and technologies motivated me to doing research on minority issues and communication in analog and digital media, which I present at conferences with policy makers such as my panel on the representation of “refugees” and “migrants” in discourses of media and politics across European countries and languages (invitation of the EU to the Jean Monnet Conference in Brussels)

Since 2020, I have been establishing an independent research and teaching area in applied linguistics with colleagues, which I call the Linguistics of Diversity and Inclusion (in digital media) and have since successfully represented at international congresses. I am engaged in international collaborations in the field of the communication of inclusion and diversity in digital media across all social domains. Those projects are based on the usage of corpus linguistic methods including tools and software for the quantitative and qualitative contrastive analysis of the communication of diversity and inclusion across several languages, cultures and countries.

This extensive applied linguistic book, focusing on several linguistic disciplines, in particular empirical discourse analysis and the communication in the interaction between media and politics, was written at the University of Regensburg, the Otto-Friedrich University of Bamberg, and the Alpen-Adria University of Klagenfurt, and submitted in Klagenfurt. This monograph received the highest possible rating of *very good - with distinction*. The manuscript, which comprises approx. 340 pages without appendix (with appendix 410 pages, incl. partial corpus), was positively evaluated and published by the editors of the series "**Linguistik - Impulse & Tendenzen**" after a double anonymous peer review process at de Gruyter.

#### - Book Description

My corpus linguistic monograph combines qualitative and quantitative methods of Corpus Linguistics. Based on the data set, the argumentative use of modal verbs and their function for persuasive (convincing) argumentation in selected German federal press conferences between 1990 and 2018 are empirically analyzed across multiple disciplines in the field of German (applied) linguistics. In this scientific contribution, modal verbs and argumentation in the process of conversation between participants from politics and media on the way to consensus negotiation are examined and discussed under the influence of journalistic interaction on modal verb use in the media and political negotiation process in the discourse context. The book is also methodologically relevant from the perspective of applied quantitative and qualitative communication research, and was written using innovative corpus linguistic tools and techniques. This book's interdisciplinary roots in applied communication research in Germanic linguistics demonstrates that I can use my applied research skills to do relevant research with data mining that can subsequently contribute to optimizing inclusive communication in professional communication and digital societies.
